

Funding & benefits

Pupils receive awards of £65,000 per annum (reviewed annually). £20,000 of the pupillage award may be paid in advance for living expenses during the BPTC.

As a junior tenant you would receive a number of benefits including: subsidised travel and conference fees; no rental charge during your first 15 months of tenancy and no receipts charge for the first 6 months; subsidised membership of key professional associations for the first 2 years; and assistance and training in financial planning and business development.
